Subject: Notification of Community Air Monitoring Data at Paradise Unified School District for Camp Fire Incident, Butte County, California from April 8 – 13, 2019

Dear Ms. John,

At the request of CalRecycle, Tetra Tech, Inc. (Tt) performed air monitoring from April 8 to April 13, 2019 at Paradise Unified School District, Paradise, California as part of the response to the Camp Fire Incident. This monitoring was performed under the direction of Matthew M. Soltis, Certified Industrial Hygienist (CIH) at Tt. Air monitoring data includes results obtained using real-time particulate monitoring instrumentation. The monitoring results presented in this letter were obtained during fire debris removal activities performed in the vicinity of Paradise Unified School District.

The ambient air monitoring results for community air monitoring at Paradise Unified School District from April 8 – 13, 2019 are summarized in the attached table. Ambient air monitoring was performed at Paradise Unified School District from Monday, April 8 through Saturday, April 13. Debris removal activities were completed during working hours from April 8 – April 13. Figure 1 depicts the locations of all debris removal sites within ½ mile of Paradise Unified School District that were active from April 8 – 13, 2019.

Fugitive dust concentrations may be considered significant at concentrations above the listed screening levels presented in the attached table. The screening levels were specified by the California Air Quality Management District, reflecting acceptable levels of ambient air quality conditions for substances that were included in this evaluation.

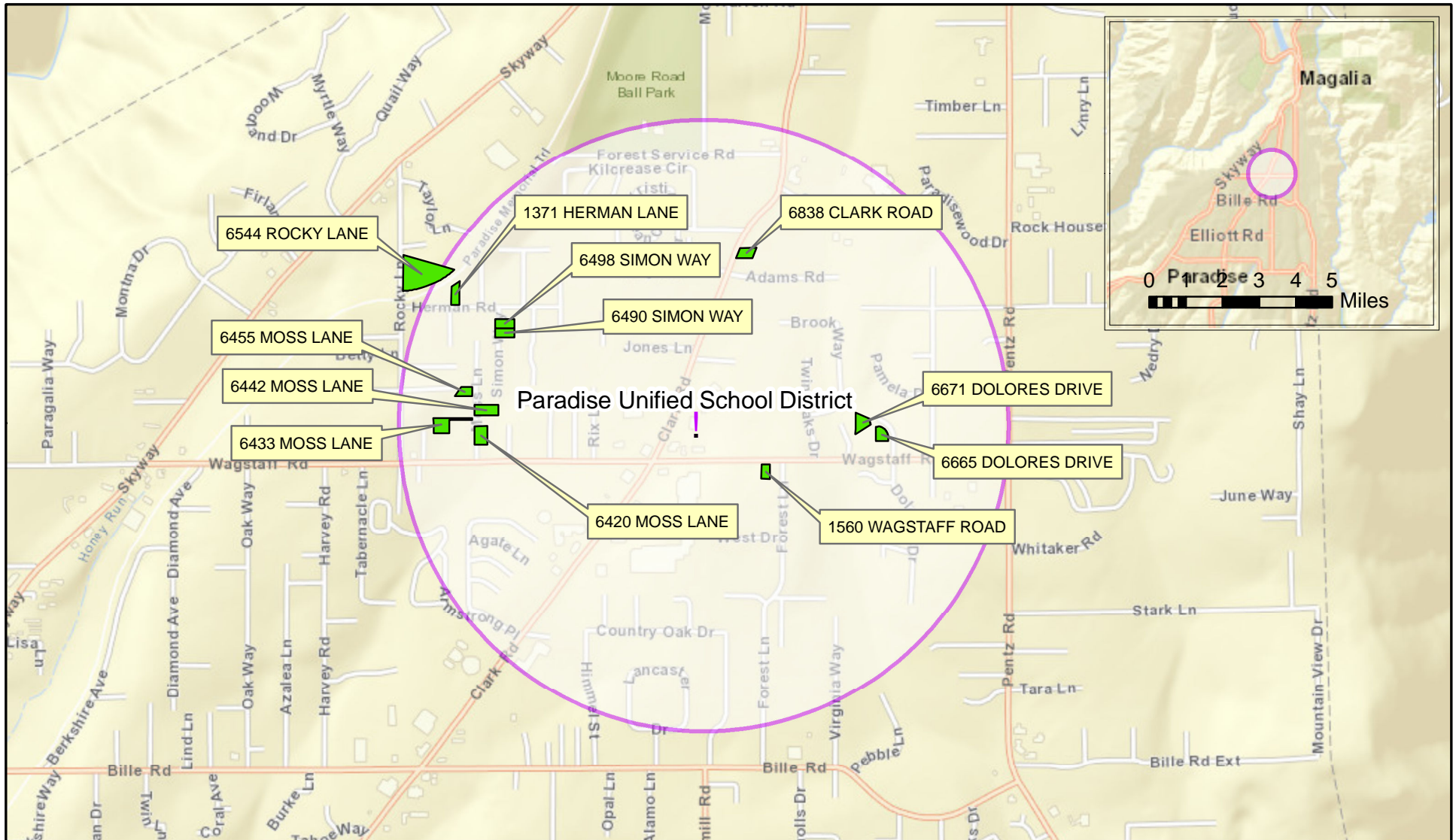
